- v. Visa fee to be paid in RMB (Renminbi) in cash.
- vi. Applications accepted from 8 AM to 3 PM (Monday to Friday) at Visa Application Center for normal passport holders.
- vii. Collection of passports from 8 AM to 3 PM (Monday to Friday) at Visa Application center for normal passport holders.
- viii. Diplomatic and Public Affairs passport holders should directly apply at the Consulate.
