One recent passport size photograph (Blue Back ground) to be attached with each application form.

This form should be printed on A4 size paper. Forms which are incorrectly filled in or are illegible or incomplete in any respect cannot be processed. If information furnished is found to be incorrect, visa is likely to be refused or cancelled if already given.

Please ensure that your passport is valid for 6 months from the time of application.

Visa Fee to be paid in RMB (Renminbi) in cash.

Submission and collection of applications and passports from 8 AM to 3 PM (Monday to Friday) at Visa Application Center for Ordinary passport holders.
