- i) One form to be filled in by each applicant.  
(Additional Proforma to be filled by applicants of Pakistani origin whose parents or grandparents have held nationality of Pakistan at any time)
- ii) One recent passport size photograph to be attached with the application form
- iii) This form should be printed on A4 size paper. Forms which are incorrectly filled in or are illegible or incomplete in any respect cannot be processed. If information furnished is found to be incorrect, visa is likely to be refused or cancelled if already given.
- iv) Please ensure that your passport is valid for six months from the time of application.
- v) Visa fee to be paid in RMB (Renminbi) in cash.
- vi) Submission of Applications and Collection of passports from 8 AM to 3 PM (Monday to Friday) at Visa Application Center for ordinary passport holders.
- vii) Applicants holding ordinary passports should contact the Visa application centre only for visa related enquiries at 010 84477511 / 84476217 or email at infopek@vfs-india.com.cn
- viii) Diplomatic and Service passport holders should directly apply at the Indian Embassy between 9 AM to 11 AM (Monday to Friday). Collection of Passports from 9 AM to 11 AM (Monday to Friday). - ix) Normal visa processing time is 7 days after the day of submission.
